This constitutes the undersigned Homeowner(s) claim (the "Claim") under Pure Solar Now division of Home-Tec International, Inc. (the "Company") Limited Energy Savings Guarantee (the "Guarantee")

By initialing each of the below statements, the undersigned Homeowner(s) hereby represent, warrant and confirm to the Company and swear and affirm to the truthfulness and accuracy of the following statements:

\_\_\_\_ The Residence's HVAC system's manufacturer's instructions regarding operation and maintenance of the HVAC system have been followed and the HVAC system has been inspected and maintained at least once subsequent to the System's installation and all HVAC filters have been replaced at least monthly.

\_\_\_\_ I/we have followed and complied with the maintenance and operational instructions recommended by the manufacture of the solar hot water system (which is an integral part of the System).

### Instruction and Required Documentation:

- In order to timely submit the Claim, this Claim Form must be fully completed and, together with all required attachments, mailed to Pure Solar Now, 13236 N. 7<sup>th</sup> Street #4-306, Phoenix, AZ 85022 no later than 60 days following the anniversary date of which the System was installed. The postmark date shall be deemed the date of mailing. You must include a copy of the savings guarantee you received at the time of purchase.
- Full and complete copies of the 12 monthly invoices for electricity, gas and/or propane for the 12 calendar months (i) immediately preceding and (ii) immediately following the month in which the System was installed must be enclosed with the Claim Form (24 months total).
- Copies of any and all invoice(s) in connection with the maintenance and service of the Residence's HVAC system must be enclosed with this Claim Form.
- Copies of HVAC Filter Receipts' (or other adequate proof) showing that filters were purchased and replaced on a monthly basis.
- The Company reserves the right to inspect the Residence and Property and request additional written information.

This Claim must be approved by the Company and is contingent upon the answers provided by the Homeowner(s) to the Company; the accuracy of all statements made by the Homeowners(s) on this Claim Form and the required documentation being furnished to the Company.

Claim Forms and copies of all documentation listed above must be mailed to the Company within 60 days of the anniversary date the System was installed (the "Deadline"). The postmark date on the envelope containing the Claim Form shall be deemed to be the date of mailing. Any Claim Form mailed after the Deadline will be rejected as not timely. In the event the Claim Form is timely mailed, but is incomplete or does not contain the required enclosures, it will be returned to the Homeowner(s) who must correct all deficiencies and mail back the Claim Form to the Company with all required enclosures within the later (i) seven calendar days from the date the Claim Form is mailed back to the Homeowner(s) by the Company (with the postmark deemed to be the date of mailing) or (ii) prior to the Deadline. Failure to timely mail back the corrected Claim Form will result in the Claim being rejected as untimely resulting in the lapse of the Guarantee; and in such case, no payment on the Claim will be made. Homeowner(s) acknowledge that it is Homeowner(s) responsibility to ensure that this Claim Form is properly completed and that all required documentation is provided to the Company; that the Claim Form will only be returned to the Homeowner(s) once in order to correct any deficiencies; and in the event Homeowner(s) fail to return the claim Form without correcting all such deficiencies, the Claim will be summarily rejected and Homeowner(s) will not be entitled to receive any payment under the Guarantee.

I(we) the Homeowner(s) affirm that except as otherwise specifically set forth herein, no changes have occurred which could otherwise serve to void the Guarantee and that all information and statements contained herein and provided to the Company are true and correct to the best of my/our knowledge.

I(we) acknowledge that should our Claim be accepted, any payment will be made solely in accordance with the terms of the Guarantee that I/we received at the time I/we purchased the System. I/we further acknowledge and agree that the Company has previously paid me/us any refund, rebate and/or interim payment under the Guarantee (collectively, "Prior Payments"), any Prior Payments will be deducted from any amounts which the Company determines are due on account of this Claim. I/we further acknowledge and agree that any payment by the Company on this Claim shall constitute full satisfaction of the company's entire obligation to me/us under the Guarantee.
